Infrastructure Funding (SB 1/HB2)

Over \$26 billion appropriated to TxDOT for planning, construction, and maintenance of the state highway system



Civil Jurisprudence Reform (HB 19)

Major tort reform that reduces opportunities for trial lawyers to manipulate evidence at trial to seek millions in damages



Environmental Regulation (HB 4472)

35% of TERP Funds, as well as all unobligated TERP funds at the end of a biennium, will be transferred to TxDOT to be used on CMAQ projects in non-attainment counties
